# END HUNGER IN CALVERT COUNTY BIKE RIDE WAIVER FORM

Fully understand that the activity involves risk and dangers of serious bodily injury; these risk and dangers may be caused by my own actions, or inactions, the action or inactions of others participating in the activity, the condition in which the activity takes place, or the negligence of the releasees name below, there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time and I fully accept and assume all risks and all responsibility for losses, cost, and damages I incur as a result of my participation or that of the minor that I have signed for in the activity.
